### **Non-Voting Affiliate Membership Classes & Dues**

Affiliates may be individuals, businesses, and other organizations that seek to support the mission of the Association of Mobility Managers. The Board of Directors shall have authority to admit any individual or organization as an affiliate, to recognize representatives of affiliates, and to make determinations as to affiliates' rights, privileges, and obligations. At no time shall affiliate information be shared with or sold to other organizations or groups without the affiliate's consent. At the discretion of the Board of Directors, affiliates may be given endorsement, recognition, and media coverage at fundraising activities, clinics, other events, or on the Association of Mobility Managers website. Affiliates have no voting rights and are not voting members of the Association of Mobility Managers. The Non-Voting Affiliate Membership classes and annual dues shall be as follows:

1. Individual Affiliate – any individual who supports the mission of the Association of Mobility Managers but does not provide Mobility Management services. The annual membership dues for an Individual Affiliate are \$50.00.
2. Non-Emergency Medical Transportation (NEMT) Broker Affiliate – any organization who provides NEMT brokerage services for Medicaid recipients. The annual membership dues for NEMT Brokers are \$5,000.00.
3. Local Governmental Agency Affiliate – any state government, county government, or municipal government agency. The annual membership dues for a Local Governmental Agency Affiliate will be:
  - a. State: \$1,000.00
  - b. Rural County (less than 50,000 residents): \$250.00
  - c. Small Urban County (50,000 to 200,000 residents): \$500.00
  - d. Large Urban County (over 200,000 residents): \$750.00
  - e. Rural Municipality (less than 50,000 residents): \$250.00
  - f. Small Urban Municipality (50,000 to 200,000 residents): \$500.00

- g. Large Urban Municipality (over 200,000 residents): \$750.00
  - h. Tribal: \$200.00
4. Public Transit Agency Affiliate – any public transit agency which does not directly provide Mobility Management services or contracts with a third-party organization to provide Mobility Management services. The annual membership dues for a Public Transit Agency Affiliate are:
    - a. Rural: \$250.00
    - b. Small Urban: \$500.00
    - c. Large Urban: \$750.00
  5. Public Housing Agency Affiliate – any public housing agency which does not directly provide Mobility Management services or contracts with a third-party organization to provide Mobility Management services. The annual membership dues for a Public Housing Agency Affiliate are:
    - a. Rural: \$250.00
    - b. Small Urban: \$500.00
    - c. Large Urban: \$750.00
  6. Partnering Organization Affiliate – any not-for-profit organization (includes quasi-governmental agencies and political subdivisions) or for-profit organization which does not provide Mobility Management services but supports the mission of the Association of Mobility Managers. The annual membership dues for a Partnering Organization Affiliate are:
    - a. Not-for-Profit Organization: \$2,500.00
    - b. For-Profit Organization: \$5,000.00
  7. Federal Government Agency Affiliate – any Federal government agency who supports the mission of the Association of Mobility Managers. There are no membership dues for Federal Government Affiliates. Federal Government Affiliates will be recognized as partners and as supporting the mission of the Association of Mobility Managers.
